#### I. DESCRIPTION OF POSITION

The VP Finance is responsible for overseeing the use of funds throughout the year and the creation of the new budget, as well as seeking sponsorship opportunities and collaborating with external agencies. They are also responsible for developing human resource policies and procedures. The position requires chairing and working with the Finance Committee and Strategic Initiatives Funding (SIF) committee.

#### **II. PRIORITIES & PROJECT AREAS**

### 1. 2018-2019 Budget & 2017-2018 Audit

Throughout the summer months, the 2018-2019 budget was created, and the 2017-2018 audit was conducted. The budget was created through consultation with the board to help further the activities of the CFMS.

### 2. Sponsorships

At the start of this year, we renewed our major partnership contract with MD Financial for a 5-year contract length. We are currently developing sponsorship opportunities and building relationships with:

- 1) Provincial and Territorial Medical Association's (PTMAs), to become our exclusive partner for Disability Insurance
- 2) MNP, as an AGM sponsor, and possibly a longer-term sponsor, as our exclusive partner for tax services to students
- 3) Telus

### 3. Strategic Initiative Fund

In March of this year, we awarded the first round of SIF funding to 6 projects. Throughout the summer, we reviewed the SIF process and held another round of SIF funding in September, prior to AGM.

### 4. Financial Wellness

Through the National Wellness Initiative, there will be two months dedicated to financial wellness. We posted some helpful videos that were created by MD Financial Management to explain important financial concepts, and posted a few helpful resources for our members, to help with their finances.
