- 1. **Board Chair:** We recently completed the process of Board evaluations, whose results will be shared with Board Members immediately after SGM. At our Fall Board Meeting, Board Members participated in workshops on Governance and Media Relations, facilitated by the Canadian Medical Association. We had the pleasure of having Dr. Danielle Martin join us at our Winter Board Meeting to provide training in government relations and advocacy. Board Members also completed training modules in communications, self-awareness and advocacy. I continue to explore ways of providing professional development opportunities for the CFMS Board of Directors. Finally, I continue to work closely with Odell Tan, CFMS Board Vice-Chair, to further formalize the role of Board Vice-Chair which is in its first year of implementation.
- 2. **Parliamentarian:** I look forward to working with the SGM Chair, Dr. Ali Damji, to ensure that the SGM agenda, including the resolutions process, run smoothly.
- 3. **Governance Committee:** The Governance Committee has been tasked with ensuring that all Board Members, National Officers, Committees and Roundtables have Terms of Reference by AGM 2019. I am pleased to say that the vast majority of National Officer and Board Member Terms of Reference, have been approved and will be made public on

The Board, in consultation with the CFMS Representatives, has put in place a new elections schedule that will hopefully see the process ensue smoothly.
